8. City Manager's Report.

- **Employee Recognition** I would like to recognize the ongoing efforts of the City's Police and Fire department employees. They continue to perform their duties in as safe a manner as possible under difficult circumstances. The Police and Fire department staff are directly involved with other local and county agencies in the daily emergency planning in response to the Covid-19 pandemic. All City employees are currently healthy and we remain at full staffing.
- Maintaining Operations The City and CBPU are maintaining essential functions and services even while our facilities are closed. Utility payments, permits and other "office" services are still available by calling City Hall at 279-9531 or going online at www.coldwater.org. In addition, customers and residents can use the drop box in front of City Hall. The City's Department of Municipal Services is working as necessary to pick up yard waste, patch pot holes and other required maintenance. Mowing will begin in the next couple of weeks to maintain the City's parks and cemeteries.
- 2020 Census Please take this time as you are staying home to participate in the 2020 US Census. You can take the ten-question survey even without having received a letter or post card. The City needs every resident to participate as it positively impacts the amount of State and Federal funding that we receive and helps determine political representation at the State and Federal level. - Community Events Update As you may have already heard, the annual Mother's Day
 Car Show & Swap Meet has been canceled for this year. For other large upcoming
 public events such as the City's annual Memorial Day Parade and Ceremony, River
 Through Time (Civil War Days) and Strawberry Fest, we are delaying any decisions until
 the end of the month or until the organizers of those events notify the City of their
 intentions. Announcements will be made in the press and the City's social media sites.
- Yard Waste Pick Up Resumes The City of Coldwater's yard waste pickup will continue now through October. Residents can place their bagged yard waste in a paper bag on the curb off of the street and City crews will make their rounds each Monday. Brush can be placed at the curb the weekend prior to the first Monday of each month. The City's yard waste drop-off site on Industrial Avenue is closed until the Governor's Executive Order to Stay Home Stay Safe is lifted.

 Code Enforcement Update – With the current Stay Safe Stay Home executive order, the City has suspended most building and property maintenance code inspections, enforcement and abatement. However, we would like to remind residents that it is unlawful to park on the grass in the front yard, grass should be kept to no higher than six inches and we ask residents to keep yards free of litter and junk. In addition, open burning of garbage, brush or yard waste is not allowed in the City. Please help keep Coldwater a beautiful community in which to live and work.

- Happy Easter! Coldwater is a great community. There are many examples of volunteerism, donations and going "above and beyond" for our neighbors. While difficult, we will all get through the current situation by working together. I hope you have a great Easter weekend. Be safe, stay home and stay healthy!
