Please keep a copy for your records.
2. **Proof of Purchase:** A copy of the original contractor invoice itemizing the purchased equipment must accompany the Rebate Request Form. The sales receipt must indicate the equipment type, make, model, price, and date of purchase.
3. **Payment:** Once completed paperwork is submitted, incentive payments are usually made within 30 calendar days.
