An original signed application and copy of the original purchase receipt must be delivered to CBPU Energy Optimization Program, 1 Grand Street, Coldwater, MI 49036, emailed to EOprogram@coldwater.org, or faxed to (517) 278-2947 **within 60 calendar days of purchase**. Please keep a copy for your records.
2. **Proof of Purchase:** A copy of the original sales receipt itemizing the purchased equipment must accompany the Rebate Request Form. The sales receipt must indicate the equipment type, make, model, price, and date of purchase.
3. **Payment:** Once completed paperwork is submitted, incentive payments are usually made within 30 calendar days. Incomplete applications will either delay payments or result in denial of application approval. The Coldwater Board of Public Utilities reserves the right to refuse payment and participation if the customer violates program terms and conditions.
